• We stepped up our support in Ethiopia to bring legal advocacy to our partners working against forced land evictions and human rights violations such as arbitrary detention and torture that accompany the forcible removal of indigenous and local people.

Our reports and successful advocacy led to the US 2015 Appropriations Bill again containing provisions to ensure US development funds are not used to support forced evictions in Ethiopia.

• Our campaign to shift policies of the World Bank, and our allied project—Our Land Our Business—joined by almost 300 civil society groups continued to challenge the pro-industry, anti-small farmer policies of the Bank. For example, at the annual meetings of the World Bank and IMF, held in Peru (October 6-11, 2015), the first time ever in Latin America in nearly 50 years, the Bank's goal was to showcase the country as the poster child. However, Bank-advised "development" model, based on promotion of export of raw materials and deregulation reforms has drastically increased social and environmental conflicts in the country. In 2014, there were an average of 200 social conflicts every month in Peru, largely related to mining activities.

In partnership with our Latin American members, including SERVINDI and the NGO Derecho, Ambiente y Recursos Naturales, the campaign hijacked the World Bank's discourse in Peru. The Oakland Institute's report, Peru, The Poster Child of the World Bank in Latin America, exposed that while the IMF and World Bank uphold Peru as economically successful, it is the rich corporations that have benefitted from the Bank advised development strategy while most Peruvians have been left behind with a

toxic legacy and degradation of their lands by mining and oil companies.

- In June 2015, the Oakland Institute released the first independent report on the state of human rights since the end of 26-year civil war in Sri Lanka in 2009. The Long Shadow of War: The Struggle for Justice in Postwar Sri Lanka, exposed that a silent war continues in which thousands of Tamils, mostly Hindus and Christians, are still internally displaced and subject to military occupation and fierce discrimination by the predominantly Buddhist Sinhalese majority.

The second report, Where are the Disappeared... brought forward testimonies from dozens of people whose family members were taken away by the army: never to be heard from again. And despite the government's promise to engage in a process of truth and reconciliation, thousands remain missing. The UN in 2012 referred to more than 70,000 missing with other estimates twice that high.

Our reports, accompanied by an intense press strategy, put their stories – a huge human rights tragedy—largely ignored, onto the pages of Le Monde, The Guardian, The Hindu, Reuters, and all other major press in Sri Lanka, India, Asia, and Canada.

- At the COP21 summit in Paris, we released 33 case studies that shed light on the tremendous success of agroecological agriculture across the African continent in the face of climate change, hunger, and poverty. These case studies provide irrefutable facts and figures on how agricultural transformation—respectful of the farmers and the environment—can yield immense economic, social, and food security benefits while ensuring climate justice and restoring soils and the environment.

Agriculture, forestry, and other land use are responsible for nearly a quarter of all

greenhouse gas emissions from human activity. According to the International Panel on Climate Change, emissions from these sectors have almost doubled over the past 50 years, and could increase by an additional 30 percent by 2050. The use of synthetic fertilizers is the fastest growing source of agriculture GHG emissions, having increased 37 percent since 2001. And yet we are told over and over that Africa needs a new Green Revolution, more synthetic fertilizers, and genetically modified crops. These case studies debunked these myths and highlighted the multiple benefits of agroecology, including affordable and sustainable ways to boost agricultural yields while increasing farmers' incomes, food security, and resilience.

Future Plans

Our work provides communities with a stronger voice and an opportunity to come up with their own solutions. The Institute is incessantly called upon by indigenous groups and NGOs from around the world as well as student groups, family farmer groups, and organizations in the US seeking partnership to document and advocate against the trend of land grabs and the corporatization of agriculture around the world.

In 2016 we will maintain the existing momentum to create new opportunities and leverage openings resulting from our work. Some of our specific plans include:

- Continued monitoring of land investments and land policies to take strategic and timely action. Producing fresh materials around land issues.
- Continue support for local partners involved in the defense and the promotion of land rights in Africa, Asia-Pacific, and the Americas.
