The Bolloré Group is a major supplier to the United Nations, which pay Bolloré over US\$50 million every year for logistics and other services. Between 2015 and 2019,<sup>1</sup> different United Nations entities signed over 200 contracts with the Group, for a value of over a quarter billion dollars. The main clients were the United Nations Procurement Division (US\$74 million), UNICEF (US\$45 million), and World Food Programme (est. around US\$100 million).<sup>2</sup> These numbers are very conservative estimates as data is not made public for a number of United Nations entities such as the World Health Organization and because many transactions are not made public.<sup>3</sup>

In addition to its activities in logistics, the Bolloré Group is involved in rubber and oil palm plantations through its participation in the SOCFIN Group,<sup>4</sup> which controls close to 400,000 hectares of concessions for plantations in Asia and Africa.<sup>5</sup> For years, SOCFIN has been accused of land grabbing and widespread human rights violations.<sup>6</sup> Repeatedly, after losing their lands to the company for

the oil palm and rubber exploitation, local communities in Africa and Asia have been subjected to violence, intimidation and severe distress.

Furthermore, the Bolloré Group has also been accused of corruption and illegal practices in a number of deals involving port concessions in Africa. Vincent Bolloré and top executives of the Group pleaded guilty and were fined in February 2021 by a French court on corruption charges related to securing port concessions in Africa.

Given this documented history of accusations of human rights violations, illegal practices, and corruption, for the United Nations services, agencies, and programs to do business with the Bolloré Group appears as a blatant violation of the United Nations Supplier Code of Conduct, the United Nations' Guiding Principles on Business and Human Rights, and the agreement signed with the Group under the United Nations Global Compact.



## Bolloré's Involvement in Land Grabbing and Human Rights Violations Through SOCFIN

For years, SOCFIN has been accused of being responsible for land grabbing and widespread human rights violations.<sup>7</sup> Repeatedly, after losing their lands to the company for oil palm and rubber exploitation, local communities in Africa and Asia have been subject to violence, intimidation, and severe distress.

- On May 20 2020, the Ijaw-Gbene village in Okomu Kingdom, Edo State, Nigeria, was allegedly burnt down<sup>8</sup> by security staff of SOCFIN's subsidiary, Okomu Oil Palm Plantation Plc., along with members of the Nigerian army.
- In Liberia, 22 Indigenous villagers filed a complaint at the International Finance Corporation<sup>9</sup> in May 2019 against another SOCFIN subsidiary, the Salala Rubber Corporation, for illegal land grabs, sexual violence, and intimidation of human rights defenders.
- In Cameroon, the security company hired by SOCAPALM has been accused of violence towards locals and in 2010, the NGO Sherpa filed a complaint before the OECD National Contact Point regarding SOCAPALM's activities.<sup>10</sup>
- In May 2019, ten NGOs and unions brought a lawsuit against the Bolloré Group in the French courts<sup>11</sup> to force implementation of an action plan the company had agreed to under a mediation process handled by the OECD.<sup>12</sup>
- In Sierra Leone, dozens of land rights defenders, critical of the way SOCFIN's subsidiary SAC has taken control over their land, have been subjected to judicial harassment and arrests for the past eight years. Six land rights defenders members of Malen Affected Land Owners Association in the Pujehun District were sentenced to six months of jail in 2016.<sup>13</sup>
- 80 plaintiffs from the Bunong Indigenous communities of Cambodia are suing the Bolloré Group and its subsidiary Compagnie du Cambodge<sup>14</sup> in a French court for the loss of land and livelihoods it has inflicted to them as a result of the plantations managed by SOCFIN-KCD.<sup>15</sup>

The list goes on but SOCFIN and Bolloré typically refute criticism of their operations.<sup>16</sup> They have in several occasions refused negotiations or mediations processes,<sup>17</sup> and when a mediation process was initiated, the group refused to implement measures to improve the living and working conditions on the plantations, as was the case in Cameroon.<sup>18</sup>

Instead of addressing the many serious issues afflicting their plantations, the Bolloré and SOCFIN groups have led aggressive legal action in African and European courts against NGOs, journalists, media outlets, and even local communities reporting on their wrongdoings. Over 20 defamation suits have been brought by Bolloré and SOCFIN over the past 12 years.<sup>19</sup>

## Accusations of Corruption and Illegal Practices around Port Concessions in Africa

The Bolloré Group has been mired in a number of scandals regarding the concession of ports in West Africa. Former CEO Vincent Bolloré's was taken into police custody in 2018 for corruption and bribery of public officials in Conakry, Guinea, and Lomé, Togo.<sup>20</sup> Bolloré and two other top executives were charged for a scheme that used the influence of Havas, a subsidiary specialized in public relations and media advertising, to support the election of Guinean president Alpha Condé and Togolese president Faure Gnassingbé in exchange for favorable decisions around the award of port concessions.<sup>21</sup>

Back in 2013, Ivorian commerce minister Jean-Louis Billon alleged impropriety by the Bolloré Group in securing port concessions in the Cote d'Ivoire city of Abidjan.<sup>22</sup> Although Bolloré was allowed to construct a second container terminal at the port, Billon criticized the move, insisting that the allowance violated the nation's laws on competition and further strengthened Bolloré's monopoly on the nation's transport sector.<sup>23</sup>

In July 2019, the Bolloré Group and its partner Maersk, opened a new and highly profitable container port at Ghana's largest port of Tema, but Ghana's Transport Ministry has since pointed to serious flaws in the award of

the concession in a report.<sup>24</sup> The ministerial report found that the container terminal contract was awarded without a proper bidding process in violation of national procurement laws. It also showed that Bolloré and its partner overstated planned investment to earn tax breaks and reduced the Ghanaian government's share in revenues.<sup>25</sup>

In Cameroon, many questions have been raised around the award of port concessions for Douala port as well as the new deep-water port of Kribi to the Bolloré Group.<sup>26</sup> Bolloré lost the concession of the port of Douala at the end of 2019, but not before attempting to seek influence from Cameroonian president Paul Biya to renew their contract.<sup>27</sup>

On February 23rd 2021, Vincent Bolloré and two other company executives pleaded guilty on corruption charges and accepted to pay a fine of 375.000 euros each to have legal proceedings against them dropped in the criminal case in Togo. Indicted for the counts of bribery of a foreign public official and complicity in breach of trust, the Bolloré Group recognized the charges and accepted to pay a fine of 12 million Euro (US\$14,5 million) in the same case. However, the presiding judge rejected the deal with the three individuals, insisting that they stand trial under criminal charges.<sup>28</sup>



## Bolloré's Control Over SOCFIN

As described in the graph below, the Bolloré Group and SOCFIN have close ties through a complex web of subsidiaries and participations.



The Bolloré Group is a major shareholder of SOCFIN, holding 39.4 percent of the capital.<sup>30</sup> Though Vincent Bolloré has repeatedly argued that his Group has a minority share in the SOCFIN Group and is not responsible for its management,<sup>31</sup> he is member of the Board of Director of the main entities of the SOCFIN Group.<sup>32</sup> In addition, several family members also hold prominent positions within the SOCFIN corporate structure. These include Cyrille Bolloré,

son of Vincent and current CEO of the Bolloré Group, who represents Bolloré Participations at the Board of Directors of SOCFINAF; and Cédric de Bailliencourt, nephew of Vincent, chairman of several subsidiaries within the Bolloré Group, who represents Bolloré Participations as a non-executive director on the Board of Directors of SOCFIN, SOCFINASIA, and SOCFINDE, among others.

## Contracts in Blatant Violation of the United Nations Codes of Conduct, the United Nations' Guiding Principles on Business and Human Rights, and the United Nations Compact

The United Nations has strict guidelines and principles regarding business and human rights abuses. The United Nations Supplier Code of Conduct lays out the requirements to which suppliers and private companies doing business with United Nations entities are subjected.<sup>33</sup> The United Nations Guiding Principles on Business and Human Rights lay out additional principles that businesses have to follow in relation to human rights.<sup>34</sup>

The United Nations Supplier Code of Conduct, Paragraph 10 states that *"The UN expects its suppliers to support and respect the protection of internationally proclaimed human rights and to ensure that they are not complicit in human rights abuses."* Regarding corruption, *"the UN expects its suppliers to adhere to the highest standards of moral and ethical conduct, to respect local laws and not engage in any form of corrupt practices, including but not limited to extortion, fraud, or bribery."* (Paragraph 18)

Additionally, the United Nations' Guiding Principles on Business and Human Rights require *"Business enterprises [to] respect human rights."*<sup>35</sup> *This means that they should avoid infringing on the human rights of others and should address*

*adverse human rights impacts with which they are involved."* (Paragraph 11). They further state that *"The responsibility to respect human rights requires that business enterprises: (a) Avoid causing or contributing to adverse human rights impacts through their own activities, and address such impacts when they occur; (b) Seek to prevent or mitigate adverse human rights impacts that are directly linked to their operations, products or services by their business relationships, even if they have not contributed to those impacts."* (Paragraph 13). The Principles also require businesses *"to carry out human rights due diligence"* (Paragraph 17) as well as to conduct remediation when *"they have caused or contributed to adverse impacts"* (Paragraph 22).

The Bolloré Group is also part of the United Nations' Global Compact,<sup>36</sup> a voluntary initiative that aligns businesses' operations with human rights, labor, environmental, and anti-corruption goals. Under the Global Compact, businesses must agree to align with their Ten Principles,<sup>37</sup> including Principle 1: Businesses should support and respect the protection of internationally proclaimed human rights; Principle 2: make sure that they are not complicit in human rights abuses, and Principle 10: Businesses should



work against corruption in all its forms, including extortion and bribery.<sup>38</sup>

Based on the above, SOCFIN's activities clearly violate several of the requirements of the Supplier Code of Conduct and multiple principles of the United Nations' Guiding Principles on Business and Human Rights. The Bolloré Group is also in violation of the commitment it made through the Global Compact.

Furthermore, some of the United Nations contracts with the Bolloré Group involve Logistics hubs such as Douala in Cameroon from where the Group handles the majority of the World Food Programme's logistics operations for Cameroon, Chad, the Central African Republic, Nigeria and

Congo Brazzaville.<sup>39</sup> The contract for "the management of customs formalities as well as the stevedoring, warehousing and delivery of goods intended for humanitarian operations" was renewed in November 2020.<sup>40</sup> Dubbed by Bolloré as "a long-standing partner," WFP appears to have renewed this agreement worth tens of millions of dollars every year since at least 2015. Given the legality and corruption issues discussed above around port concessions in Africa, blanket contracts for hubs in a port such as Douala raise serious questions.

In light of the above, it is inappropriate for any United Nations service, agency, and program to conduct business with and award contracts paid through public funding to companies affiliated with SOCFIN and the Bolloré Group.
