COUNT II:

MALICOUSE DAMAGE TO PROPERTY CONTRARY TO SECTION 339 (1) AS READ WITH SECTION 339(3)(b) OF THE PENAL CODE.

STEALING CONTRARY TO SECTION 268 AS READ WITH 275 OF THE PENAL CODE

AMINA HUSSEIN KULO: On the 8th day of may 2023 at northern rangers' trust offices at Korbessa location, Merti sub-county within isiolo count jointly with others before court stole 350 bags of cement, 6 (six) wheel barrows, 58 (fifty-eight) pieces of iron rods and 8 (eight) pieces of 200litres drums all valued at KSH 415,000/=the property of northern rangers' trust.

COUNT IV.

GREVIOUS HARM CONTRARY TO SECTION 234 OF THE PENAL CODE

AMINA HUSSEIN KULO. On the 8th day of may 2023 at northern rangers' trust offices at Korbessa location, Merti sub-county within Isiolo county, unlawfully did grievous harm to NO 250211 PC NICHOLAS ODERO

COUNT V

COUNT VII
