Nor, do I believe, have you spoken with the District Executive Officer or the District Commissioner, or the Prime Minister. It would be difficult to get them to come to Oakland or talk by Skype. This is why Mr. Garbus suggested that if you had visited us in Tanzania that your views would be very different.

However, that being said, would a skype call suffice?
