A. PETITIONERS' NAMES AND ADDRESS

1. The Petitioners bring the Petition on their own behalf and on behalf of residents and members of the indigenous Pokot community residing on the community land which is jointly and

indivisibly owned by them and carrying out nomadic pastoralism as a way of life in the areas of Endugh, Kasei, Sekerr, Masol, Lomut and Weiwei wards in West Pokot County. The Petitioners' address of service for purposes of this Petition shall be through **RONOHLAW AND ASSOCIATES ADVOCATES, I&M BANK HOUSE, 7TH FLOOR, P. O. BOX 373300-00100, NAIROBI.**

B. RESPONDENTS' NAMES AND ADDRESS

2. **THE 1st** Respondent is a private organization carrying out conservancy operations in various counties within the Republic of Kenya. (*Service of the Petition shall be effected through the Petitioners' Advocates*).
3. **THE 2nd** Respondent is a community conservancy registered by the the Kenya Wildlife Conservancies Association. (*Service of the Petition shall be effected through the Petitioners' Advocates*).
4. **THE 3rd** Respondent is a community conservancy registered by the Kenya Wildlife Conservancies Association. (*Service of the Petition shall be effected through the Petitioners' Advocates*).
5. **THE 4th** Respondent is a level of government established under Article 176 of the Constitution of Kenya 2010, as read together with the County Government Act 2012 Laws of Kenya, mandated to promote National Values in accordance with the Constitution and who is entrusted under the Community Land Act to hold land in trust on behalf of the community. (*Service of the Petition shall be effected through the Petitioners' Advocates*).

C. PETITIONERS' LOCUS AND COURT'S JURISDICTION

6. **YOUR** Petitioners aver that Article 3 as read together with Articles 22(1) and 258 Constitution of Kenya 2010 enables them to Petition this Honourable Court for enforcement of theirs and/or other persons' rights violated or are under the threat of being violated.

7. **YOUR** Petitioners aver further that this Honorable Court is clothed with requisite jurisdiction under Articles 162(2) and 159 Constitution of Kenya 2010 as read together with Section 13 of the Environment and Land Court Act (No. 19 of 2011) to hear and determine any question regarding violation of rights, determine constitutionality of any act or omission as well as interpret the Constitution in respect to the violation of the right to public participation, land rights, environmental protection, access to information and socio-economic and cultural rights among others.
8. **THIS** Honourable Court is charged with the fundamental duty to observe, respect, protect, promote and fulfill the rights and fundamental freedoms in the Bill of Rights in terms of Article 21(1) of the Constitution of the Republic of Kenya, 2010.
9. **THAT** Your Petitioners aver that this Honorable Court's constitutional mandate aforesaid, is exercised by issuing such orders and writs as it deems just and fit to state organs and/or any person to act within the law and fulfill its constitutional obligations.

D. ISSUE IN DISPUTE

10. **THE** Petition is premised on violation and/or threatened violation of the Petitioners' fundamental rights to socio-economic and cultural rights and from arbitrary deprivation thereof trampled upon jointly and severally by the 1st, 2nd, 3rd, and 4th Respondents on the following grounds:-
 - i. **THE** Respondents have unlawfully infringed on the right to public participation as there was no public participation that was done on the community members on any actions to be undertaken by the 1st-3rd Respondents on wildlife conservation or otherwise thereby locking them out from the decision making process;
 - ii. **THE** Respondents did not seek the free, prior and informed consent from the local community in accordance to the rights of indigenous communities to have a Memorandum

of Understanding through which to excise community land for use of private wildlife conservation

- iii. THE process of mapping, surveying and delineation of community land has resulted to the illegal eviction and displacement of community members towards intercommunity boundaries which has spurred intercommunity conflicts.
- iv. THE Respondents have unlawfully withheld and/or denied the indigenous community members the right to access to full and relevant information concerning the Memorandum of Understanding, the legality of their operations and their rights thereon;
- v. THE Respondents have unlawfully declined to afford the members of the local community an inclusive legal or democratic representation as the community was not represented in the drafting of the Memorandum of Understanding document and whose contents remains strange to the local community;
- vi. THE Respondents have unlawfully overtly discriminated against women, youth and persons with disabilities' interests among the marginalized Pokot community as they have never been represented in the management and/or decision making process;
- vii. THE Respondents have unlawfully infringed on the enjoyment of cultural rights though their draconian policies, plans and programs which are geared towards undermining the community members' way of life, ownership of land and cultural practices on religious sites;
- viii. THE Respondents are hoodwinking the community members through the Memorandum of Understanding as there is no Community Development Agreement duly executed between the Respondents, the community and all democratically elected leaders, religious leaders, community elders, women, youth or legal representatives on any development plans and therefore the plans by the respondents jointly and severally are not binding obligations to unduly influence members of the community;

ix. **THE** community members take issue with the contents of the impugned Memorandum of Understanding on the grounds that:

- The Community members have not been identified as key stakeholders and were never included in the execution of the Memorandum of Understanding
- The object of the Memorandum of Understanding is to undermine the cultural and traditional economic activities of the indigenous community
- There is no formal and binding agreement between the 1st -3rd and the local community as the Memorandum of Understanding serves as a formal framework between the Respondents with the exclusion of the community members
- That admission of other parties to the Memorandum of Understanding is only limited to the verification ad permission of the 1st Respondent thus not in good faith on behalf of the community
- The Memorandum of Understanding is only executed by the 1st - 4th Respondents in exclusion the community and key stakeholders such as Kenya Wildlife Services, other community leaders and community elders.
- The Memorandum of Understanding does not identify and outline obligation for and by the local community in support of the purported conservation activities
- The Memorandum of Understanding mandates the 4th Respondent to finance the private conservation activities of the 1st Respondent which is only intended to hoodwink the community members.
- The Memorandum of Understanding permits the parties therein, i.e., the Respondents to enter into any agreement with other interested persons thus excluding the local community from inclusion and public participation
- That the Memorandum of Understanding fails to apportion liability on the Respondents in the event that any injury is occasioned on the local community members owing to their actions/omissions

x. **THE** 2nd and 3rd Respondents have disguised themselves as community conservancies yet their board members have been handpicked by the 1st Respondent in order to control and

- satisfy its interest in disguise of the local community members and who disregarded the originally registered Masol Wildlife Conservancy;
- xi. **THE** Respondents have unlawfully taken upon themselves by virtue of the Memorandum of Understanding the intellectual property rights of the local community without any framework on the benefit sharing on the part of the community;
 - xii. **THE** 4th Respondents has unlawfully, illegally and or irregularly entered into an agreement without verifying that the fundamental rights of the local community to public participation have been fulfilled;
 - xiii. **THE** 1st - 4th Respondents, in breach of its statutory obligation, has declined and willfully failed to comply with the recommendations of the report of the Ad hoc Committee of the County Assembly.

The Honourable Court is thereof enjoined to protect and safeguard the Petitioners rights

E. FACTUAL BACKGROUND OF THE DISPUTE

1. **THAT** Your Petitioners represent members of the indigenous Pokot community living on the community land which is jointly and indivisibly owned by them and carrying out nomadic pastoralism as a way of life in the areas of Endugh, Kasei, Sekerr, Masol, Lomut and Weiwei wards within West Pokot County.
2. **THAT** Your Petitioners aver that *vide* a Memorandum of Understanding between the 1st and 4th Respondent, the 1st Respondent is unlawfully actively undertaking mapping activities to delineate community land for private wildlife conservation use for a term of over ten (10) years without seeking free prior informed consent of community members through adequate public participation.
3. **THAT** Your Petitioners further aver that in addition to unlawful mapping, surveying and delineation of land, the 1st Respondent is in the process of importing wildlife to graze in

the community land thereby causing tension, anxiety and insecurity incidences of impending eviction of community members.

4. **THAT** Your Petitioners aver that on or about 14th December 2020, there was an inter-community conflict along the Pokot-Turkana Boarder owing to the fact that people have been massively evicted and displaced to the porous border and where scores were injured and two school going children are in a critical condition.
5. **THAT** Your Petitioners aver that the actions by the 1st Respondent to import wildlife will consequently lead to increased cases of human and wildlife conflicts and which the community members are apprehensive that they will lose their grazing land, lives and livestock to the wild animals.
6. **THAT** Your Petitioners state that more community members are at verge of eviction if there is continued implementation of the Memorandum of Understanding which is geared towards pushing the local community into unwarranted boundary and inter-community conflicts thereby increased insecurity, indiscriminate loss of lives and property.
7. **THAT** Your Petitioners aver that the 1st Respondents in its action/omission want to impose draconian and unconstitutional by-laws on settlement and grazing activities of the local community members thus disinheriting the community of its communal land, disrupt the local community's social and economic lives as pastoralists who graze in open fields.
8. **THAT** Your Petitioners state that on 13th and 17th August 2020, the Petitioners from Masol and Weiwei respectively submitted their Petitions to the West Pokot County Assembly. The County Assembly established an *Ad hoc* Committee who invited parties for a hearing and in its final report as adopted by the County Assembly, recommended;
 - a. the halting of activities until the registration of all community land;
 - b. membership of conservancy be constituted by community members;
 - c. the respondents and all stakeholders undertake public sensitization within 60 days;

- d. all maps by the 1st Respondent be hereby revoked;
- e. the MoU between the 4th and 1st - 3rd Respondents be revoked.

These recommendations have since been overtly disregarded by the Respondents.

9. **THAT** Your Petitioners aver that the local community has over time protested against the 1st – 3rd Respondents due to the continued action/omission to flagrantly deny, violate, infringe and/or ignore the fundamental human rights and dignity of the members of the community thereby illegally evicting and displacing them from the community land.
10. **THAT** Your Petitioners have never been engaged in any reasonably inclusive public participation as members of a recognized indigenous community. As such, neither of the Respondents had the express or implied authority of local communities to enter into the impugned Memorandum of Understanding.
11. **THAT** Your Petitioners aver that the Respondents have never sought the sacrosanct right to Free, Prior and Informed Consent in the drafting of the said Memorandum of Understanding and its resultant implementation of activities either. The said Memorandum of Understanding document and its contents are strange to members of the community and have never been presented or explained to the community in a language that they understand.
12. **THAT** Your Petitioners aver that the 2nd and 3rd Respondents do not represent the interests of the community as purported in the Memorandum of Understanding for the reason that its board members were handpicked by the 1st Respondent without the knowledge and authority of the community members to disguise and masquerade as representatives of the indigenous members.
13. **THAT** Your Petitioners aver that the 1st Respondent disregarded the originally formed community conservancy duly registered as Masol Wildlife Conservancy and unlawfully conspired to the formation of the 2nd and 3rd Respondents to drive its obscure intentions.

The intentions of the 1st Respondents are to expansively delineate community land for private use.

14. **THAT** Your Petitioners were never represented through our all democratically elected leaders, religious leaders, community elders, women, youth or legal representatives. The community members are apprehensive that the Memorandum of Understanding is mischievous and amounts to abuse of the fundamental and inherent rights of the community members.
15. **THAT** Your Petitioners aver that the Memorandum of Understanding is intended to misadvise the members of indigenous community on intended plans to conserve and manage natural sources and promote development initiatives, some of which amount to the constitutional functions of the 4th Respondent. The purported Memorandum of Understanding does not constitute a binding Community Development Agreement covering the obligations and interests/needs of the local community.
16. **THAT** Your Petitioners aver that although the County Government only holds the land in trust for the exclusive enjoyment of rights of the local community, it has continued to violate the National Values and Principles of Governance being; right of access to information; land rights; and right to clean and healthy environment as provided in the Constitution and other laws, noting that it neither authenticated the activities of the Respondents nor undertook public participation on its end.
17. **THAT** Your Petitioners aver that the irregular mapping of land by the 1st Respondent is a violation of the infringing the fundamental right to privacy in the enjoyment of and full realization of the cultural rights by community members as the mapped area curves out cultural religious sites.
18. **THAT** Your Petitioners are apprehensive that the 1st-4th Respondents' actions are aimed at denying the local community their right to respect, preserve and maintain knowledge, innovations and practices as indigenous and local communities embodying traditional

lifestyles relevant for the conservation and sustainable use of biological diversity and promote their wider Petition with the approval and involvement of the holders of such knowledge, innovations and practices and encourage the equitable sharing of the benefits arising from the utilization of such knowledge, innovations and practices.

19. **THAT** Your Petitioners aver that the actions and/or omissions of the Respondents amount to forceful entry to property, thereby limiting the right to enjoyment of property.
20. **THAT** Your Petitioners aver that the Respondents jointly and severally have undermined and continuously discriminated against women youth and persons with disabilities from any engagement, management and representation.
21. **THAT** Your Petitioners aver that there are no approvals, requisite land use plan and environmental and social impact assessment if at all, and that the implementation of such projects as importing wildlife without a multiple and comprehensive environmental and social risks will violate the constitutional rights of the local community members living within the suit area.
22. **THAT** Your Petitioners aver that the suit land is mostly unadjudicated and there is no register of full members, a process that is still being undertaken by the community. The 1st -4th Respondents conniving through the Memorandum of Understanding seek to compulsorily acquire community land without public participation and in contravention with the laws and regulations governing community land.
23. **THAT** Your Petitioners are apprehensive that the Respondents have employed coercion, duress and/or undue influence on members of the community who were in opposition in order to subvert the implementation of the recommendations of the West Pokot County Assembly Report.

F. LEGAL BASIS

a. PARTICULARS OF UNCONSTITUTIONALITY

24. The 1st -4th Respondents' impugned actions/omissions violated the fundamental rights and freedoms of the Petitioners under the Constitution of Kenya, specifically to under:

- a) *Article 1* which states that sovereign power belongs to the people and which shall be exercised in accordance with the Constitution. People may exercise their power through their democratically elected leaders and the constitution delegates the power to state organs the same may be exercised.
- b) *Article 2* recognizes the Supremacy of the constitution and imports the general rules of international law as forming part of the law of Kenya,
- c) *Article 3* obligates all persons to respect, uphold ad defend the Constitution.
- d) *Article 10* enlists the National Values and Principles which binds state organs, state officers, public officers and all persons whenever they apply, interpret, make or implement any laws and policies
- e) *Article 19* recognizes the integral part of the Bill of Rights as the framework for social, economic and cultural policies and the purpose of recognizing and protecting human rights and fundamental freedoms is to preserve the dignity of individuals and communities and to promote social justice and the realization of the potential of all human beings.
- f) *Article 20* provides that the Bill of Rights applies to all and binds all State organs and all persons and every person shall enjoy the rights and fundamental freedoms in the Bill of Rights to the greatest extent consistent with the nature of the right or fundamental freedom.
- g) *Article 21* states that it is the fundamental duty of the State and every State organ to observe, respect, protect, promote and fulfill the rights and fundamental freedoms in the Bill of Rights.
- h) *Article 22* provides that every person has the right to institute court proceedings claiming that a right or fundamental freedom in the Bill of Rights has been denied, violated or infringed, or is threatened.

- i) *Article 23* provides that High Court has jurisdiction, in accordance with Article 165, to hear and determine Petitions for redress of a denial, violation or infringement of, or threat to, a right or fundamental freedom in the Bill of Rights and the court may grant any relief including a declaration of right, an injunction and an order for compensations
- j) *Article 24* states that the Bill of rights shall not be limited except by law, and then only to the extent that the limitation is reasonable and justifiable in an open and democratic society based on human dignity, equality and freedom, taking into account all relevant factors
- k) *Article 27* provides for equal protection and benefit from the law and further states that men and women have the right to equal enjoyment of all rights including the right to equal opportunities in political, economic, cultural and social spheres.
- l) *Article 28* makes provision for the protection of the inherent right to human dignity.
- m) *Article 29* is the effect that every person has the right to freedom and security which includes being subjected to any form of violence or from being treated in an inhumane and degrading manner.
- n) *Article 35* provides for the protection of the right to information held by another person and required for the exercise or protection of any right or fundamental freedom.
- o) *Article 40* provides that every person has a right, either individually or in association with others, to acquire and own property
- p) *Article 42* states that very person has a right to a clean and healthy environment which includes the right to have the environment protected for the benefit of the present and future generations.
- q) *Article 43* provides for the economic and social rights on the highest attainable health, freedom from hunger and clean and safe water

- r) *Article 44* states that every person has the right to use the language and to participate in cultural life of the person's choice alongside with other members.
- s) *Article 48* mandates States to ensure access to justice for all persons
- t) *Article 53 (2)* states that a child's best interests are of paramount importance in every matter concerning the child.
- u) *Article 56* mandates the state to place affirmative action programs designed to ensure that minorities and marginalize groups to develop their cultural values, language and practices
- v) *Article 60* makes provision for the principles of land policy and states that land should held, used and managed in a manner that is equitable, efficient, productive and sustainable
- w) *Article 63* provides that community land shall vest in and be held by communities identified on the basis of ethnicity, culture or similar community interests. It further defines what constitutes community land. Any unregistered community land shall be held in trust by county governments on behalf of communities for which it is held.
- x) *Article 69* makes provisions for the State to ensure respect of the environment.
- y) *Article 73* makes provision for responsibilities of leadership, requiring a public trust to be exercised in a manner that is consistent with the purpose and object of the Constitution
- z) *Article 185* provides that County Assembly may make any laws that are necessary for or incidental to, the effective performance of the functions and exercise of the powers of the county government under the Fourth Schedule.
- aa) *Article 258* provides that every person has the right to institute court proceedings, claiming that this Constitution has been contravened, or is threatened with contravention

b. RELEVANT INTERNATIONAL AND REGIONAL LEGAL FRAMEWORK

25. The actions of the Respondents in the circumstances are contrary to a number of international legal instruments voluntarily and customarily agreed upon or ratified by Kenya, including;

1. Right to public participation and access to information

- i. Article 14 of the *Convention on Biological Diversity* provides that Each Contracting Party, as far as possible and as appropriate, shall Introduce appropriate procedures requiring environmental impact assessment of its proposed projects that are likely to have significant adverse effects on biological diversity with a view to avoiding or minimizing such effects and, where appropriate allow for public participation in such procedures;
- ii. Article 1 of the *Convention on the Access to Information, public Participation in Decision-making and Access to Justice in Environmental Matters* provides that in order to contribute to the protection of the right of every person of present and future generations to live in an environment adequate to his or her health and well-being, each Party shall guarantee the rights of access to information, public participation in decision-making, and access to justice in environmental matters in accordance with the provisions of this Convention
- iii. Article 2 of the *Convention on the Access to Information, public Participation in Decision-making and Access to Justice in Environmental Matters* provides that each Party shall take the necessary legislative, regulatory and other measures, including measures to achieve compatibility between the provisions implementing the information, public participation and access-to-justice provisions in this Convention, as well as proper enforcement measures, to establish and maintain a clear, transparent and consistent framework to implement the provisions of this Convention
- iv. Article 7 of the *Convention on the Access to Information, public Participation in Decision-making and Access to Justice in Environmental Matters* provides that *provides* each Party shall make appropriate practical and/or other provisions for the public to participate during the preparation

of plans and programs relating to the environment, within a transparent and fair framework, having provided the necessary information to the public.

- v. *Article 9 of the African Charter on Human and Peoples Rights* states that every individual shall have the right to receive information.

2. Freedom from discrimination

- Article 2 of the *Universal Declaration of Human Rights* provides that everyone is entitled to all the rights and freedoms set forth in the Declaration, without distinction of any kind, such as race, colour, sex, language, religion, political or other opinion, national or social origin, property, birth or other status.
- *Article 7 of the Universal Declaration of Human Rights* provides that every person equal before the law and are entitled without any discrimination to equal protection of the law
- *Article 26 of the International Covenant on Civil and Political Rights* provides that all persons are equal before the law and are entitled without any discrimination to the equal protection of the law on any ground such as race, colour, sex, language, religion, political or other opinion, national or social origin, property, birth or other status
- *Article 5 of the Convention on the Elimination of Discrimination Against Women* provides that State Parties shall take all appropriate measures to modify the social and cultural patterns of conduct of men and women, with a view to achieving the elimination of prejudices and customary and all other practices which are based on the idea of the inferiority or the superiority of either of the sexes or on stereotyped roles for men and women
- *Article 8 of the Convention on the Elimination of Discrimination Against Women* provides that State Parties shall take all appropriate measures to ensure to women, on equal terms with men and without any discrimination, the opportunity to represent their Governments at the international level and to participate in the work of international organizations.

- Article 13 of the *Convention on the Elimination of Discrimination Against Women* provides that States Parties shall take all appropriate measures to eliminate discrimination against women in other areas of economic and social life in order to ensure, the right to participate in all aspects of cultural life
- Article 14 of the *Convention on the Elimination of Discrimination Against Women* provides that States Parties shall take all appropriate measures to eliminate discrimination against women in rural areas in order to ensure, on a basis of equality of men and women, that they participate in and benefit from rural development and, in particular, shall ensure to such women the right to participate in the elaboration and implementation of development planning at all levels
- Article 44 of the *United Nations Declaration on the Rights of Indigenous Peoples* provides that all the rights and freedoms under it are equally guaranteed to male and female Indigenous Peoples

3. Right to property

- Article 17 of the *Universal Declaration on Human Rights* provides that everyone has the right to own property alone as well as in association with others and nor shall anyone be arbitrarily deprived of his property.
- Article 26 of the *United Nations Declaration on the Rights of Indigenous Peoples* provides that Indigenous Peoples have the right to the lands, territories and resources and the right to own, use, develop and control lands which they have traditionally owned, occupied or otherwise used or acquired

4. Right on culture economic social

- Article 22 of the *Universal Declaration on Human Rights* provides that everyone, as a member of society, has the right to social security and is entitled to realization, through national effort and international co-operation and in accordance with the organization and resources of each State, of the economic,

social and cultural rights indispensable for his dignity and the free development of his personality.

- Article 27 of the *Universal Declaration on Human Rights* provides that everyone has the right freely to participate in the cultural life of the community, to enjoy the arts and to share in scientific advancement and its benefits. Everyone has the right to the protection of the moral and material interests resulting from any scientific, literary or artistic production of which he is the authority.
- Article 27 of the *International Covenant on Civil and Political Rights* provides that in States in which ethnic, religious or linguistic minorities exist, persons belonging to such minorities shall not be denied the right, in community with the other members of their group, to enjoy their own culture, to profess and practice their own religion, or to use their own language.
- Article 15 of the *International Conventions on Economic Social and Cultural Rights* recognizes the right of everyone to take part in cultural life.
- Article 11 of the *United Nations Declaration on the Rights of Indigenous Peoples* provides that Indigenous Peoples have a right to practice and revitalize their culture

5. Rights of Indigenous communities

- Article 10 of the *United Nations Declaration on the Rights of Indigenous Peoples* provides that Indigenous Peoples shall not be forcibly removed from their lands and territories and that no relocation shall take place without the free, prior and informed consent of indigenous people concerned and after agreement on just and fair compensation and, where possible, with the option of return.
- Article 12 of the *United Nations Declaration on the Rights of Indigenous Peoples* provides that Indigenous Peoples have the right to manifest, practice, develop, teach, right to maintain, protect and have access in privacy to their cultural sites and the right to use and control their ceremonial objects.

- Article 18 of the *United Nations Declaration on the Rights of Indigenous Peoples* provides that Indigenous Peoples have a right to participate in decision making in matters which would affect their rights, through representatives chosen by themselves in accordance with their procedures, as well as to maintain and develop their own indigenous decision-making institutions.
- Article 22 of the *United Nations Declaration on the Rights of Indigenous Peoples* provides that particular attention shall be paid to the rights of indigenous elders, women, youth, children and persons with disabilities
- Article 23 of the *United Nations Declaration on the Rights of Indigenous Peoples* provides that Indigenous Peoples have a right to determine and develop priorities and strategies for exercising their right to development and be actively involved in developing and determining health, housing and other economic and social programs affecting them and as far as possible, administer through their institutions.
- Article 29 of the *United Nations Declaration on the Rights of Indigenous Peoples* provides that Indigenous Peoples have the right to the conservation and protection of the environment and the productive capacity of their lands or territories and resources.
- Article 31 of the *United Nations Declaration on the Rights of Indigenous Peoples* provides that Indigenous Peoples have the right to maintain, control, protect and develop their cultural heritage, traditional knowledge and traditional cultural expressions as well as the manifestations of their sciences, technologies and cultures, including human and genetic resources, seeds, medicines, knowledge of the properties of fauna and flora, oral traditions, literatures, designs, sports and traditional games and visual performing arts. Indigenous People have a right to maintain, control, protect and develop their intellectual property over such cultural heritage, traditional knowledge and traditional expressions.
- Article 32 of the *United Nations Declaration on the Rights of Indigenous Peoples* provides that Indigenous Peoples have the right to determine and

develop priorities and strategies for the development or us of their lands or territories and other resources.

c. RELEVANT LEGISLATION AND REGULATORY FRAMEWORK

1. Section 3 of the County Government Act provides for the object and purpose of the Act which is to provide for public participation and section 115 of the Act further provides that the process of Public participation is mandatory.
2. Section 4 of the Wildlife (Conservation and Management) Act provides that in the implementation of the Act, any conservation and management of wildlife shall entail effective Public Participation.
3. Section 3 of the Community Land Act binds all persons dealing with community land to be guided by the principles under Article 60 and the National Values and Principles set out in section 10 of the Constitution.
4. Section 4 of the Community Land Act provides that community land vests in the community.
5. Section 6 of the Community Land Act makes provisions related to unregistered community land and provides that the County Government holds in trust all the land, including all the money payable as compensation for compulsory acquisition until such time as when the registration shall be effected and the county government shall transfer all the money to the community.
6. Section 3 of the Access to Information Act, 2016 outlines the objectives of the Act as giving effect to Article 35 of the Constitution of Kenya and further states that the Act provides a framework for public entities and private bodies to proactively disclose information that they hold and to provide information on request in line with the constitutional principles

7. Section 4 of the access to Information Act, 2016 provides that every person has a right to information held by the state or any other person and where that information is required for the exercise or protection of any right or fundamental freedom.
8. The West Pokot County Public Participation Act, 2014 gives effect to paragraph 14 of part 2 of the Fourth Schedule of the Constitution; to establish modalities and platform of public participation in the governance of the county and connected purposes.

G. VIOLATION OF THE CONSTITUTION

- 26. WHEREAS** the Petitioners have a constitutional obligation to respect, uphold and defend the Constitution and a guaranteed right to institute court proceedings to claim that the Constitution and Bill of Rights have been contravened;
- 27. AND whereas** the Constitution of Kenya provides for fundamental rights and freedoms to be enjoyed by all citizens of the Republic of Kenya the same christened as an integral part of our democracy and social economic and cultural policies and in particular right to own land, public participation, access to information under Chapter Four of the Constitution of Kenya, 2010.
- 28. AND whereas** the State, defined to include the Respondent herein, has an obligation to promote and protect the rights and fundamental freedoms including rights to fair hearing, right fair administrative actions, freedom from discrimination among others;
- 29. AND whereas** the recognition of rights and fundamental freedom is purposed on *inter alia* realization of potential of all human beings, adoption of retrogressive and policies, actions and/or omissions unnecessarily limiting economic, social and cultural rights of the Petitioners will therefore contravene Article 19 of the Constitution of Kenya 2010. The impugned denial of the inhibits the Petitioners and other community members an opportunity to realize their inherent potentials to the greatest extent possible;

- 30. AND whereas** the bill of rights applies to all law and binds all state organs and all person, government action that unreasonably and unjustifiable limits and violates rights and fundamental freedoms outside the provisions of Article 24 are invalid for all purposes and intents. To the extent that the impugned actions which are and/or were done outside the ambit of the Constitution of Kenya, 2010, Community Act, 2016, Wildlife (Conservation and management) Act, 2013 and the County Government Act, 2012 has adverse effects on constitutional provisions and guarantees the same does not pass the threshold for limitation of rights and fundamental freedoms and must therefore be redressed;
- 31. AND whereas** the impugned actions by the |Respondents jointly and severally are discriminative to the extent that they targeted the Petitioners, the impugned actions and/or omissions threaten the Petitioners' right to equal benefit and equal protection of law.
- 32. AND whereas** the Petitioners have the right of access to information, the 1st-4th Respondents' breached the Petitioners right of access to information under Article 35 and right to a fair administrative action under Article 47 of the Constitution of Kenya, 2010.
- 33. AND whereas** the right to equality and freedom from discrimination is guaranteed by Article 27 of the Constitution of Kenya, 2010, the impugned actions and/or omissions inherently deprives the Petitioners of this Constitutional right to freedom from discrimination contrary to **Articles 27(1), (2), (4) and (5)** of the Constitution of Kenya, 2010.
34. The Petitioners bring this Petition as the most efficient means of redress and under Articles 22, 258 and 165 (2) of the Constitution of Kenya and invokes the constitutional jurisdiction of the Court to enforce Articles 2, 3, 10, 19, 22, 35, 42 and 48 of the Constitution of Kenya thereby securing and protecting the general public and Petitioner's rights from continued violation and oppression by the Respondents.
35. **THAT** because of the conduct of the Respondent outlined above, this is an appropriate case for an award of injunctive and declaratory orders as sought in this Petition.

REASONS WHEREFORE YOUR PETITIONERS HUMBLY PRAY FOR: -

1. A declaration be and is hereby issued that the Petitioners' enjoyment of their rights and fundamental freedoms secured in the Bill of Rights under Articles 27, 35, 42, and 48 of the Constitution of Kenya 2010 have been jointly and severally threatened, infringed and/or are denied by the 1st – 4th Respondents.
2. **THAT** the Honourable court be and is hereby pleased to issue a permanent injunction order stopping, prohibiting and forbidding 1st, 2nd 3rd and 4th the Respondents jointly and severally, whether by themselves, their agents, servants, representatives assignees and/or whosoever acting under their instructions/directions from entering, mapping, surveying and delineating community land, carrying out conservancy operations, importation of wildlife, evicting community members or any other activity under the Memorandum of Understanding for Collaboration in Conservation, Management, Sustainable Use of Natural Resources & to Promote Community Development Initiatives in West Pokot County as signed in December 2019 between the 4th Respondent and 1st-3rd Respondents the in the areas of Endugh, Kasei, Sekerr, Masol, Lomut and Weiwei wards within West Pokot County.
3. That the court be pleased to declare the Memorandum of Understanding for Collaboration in Conservation, Management, Sustainable Use of Natural Resources & to Promote Community Development Initiatives in West Pokot County signed in December 2019 between the 4th Respondent and 1st-3rd Respondents, all maps therefrom and any consequential documents and agreements relating to and arising from the said Memorandum of Understanding together with the activities of the 1st – 4th Respondents thereon as unconstitutional.
4. That the court be pleased to cancel and revoke the Memorandum of Understanding for Collaboration in Conservation, Management, Sustainable Use of Natural

Resources & to Promote Community Development Initiatives in West Pokot County signed in December 2019 between the 4th Respondent and 1st-3rd Respondents, all maps therefrom and any consequential documents and agreements relating to and arising from the said Memorandum of Understanding.

5. That a permanent injunction do issue against the 4th Respondent from entering into agreements on behalf of the community without undertaking public participation as mandated by law.
6. That the 4th Respondent be directed to facilitate the adjudication and registration of community land.
7. That the Petitioners be awarded general damages for loss of use of land and injuries.
8. Costs of the Petition be borne by the 1st-4th Respondents.
9. Any other Order(s) as this Honourable Court shall deem fit.
