She goes on to say "Others blame the feedback loops of the internet, where it is easy to find someone who will agree with you, no matter how barmy you are. In cyberspace, everyone can hear you scream."

At this juncture in our country with the leadership of our country talking nonsense, I believe we owe it to each other to ensure that we "have it right". For those of us who do stand against hate, bigotry and white supremacy, we must get it right. If you move forward to publish these allegations, then why are you different than those who are currently leading our country?

You have heard from Martin Garbus, from elders in videos, from John Bearcroft and me through various emails.

You have asked us for comments, responses and our perspective on false allegations, incorrect information, and your research that paints a "grim view".

It is clear to us that the Oakland Institute has actually not done any proper research to prove if the allegations are true or not. is the job of Oakland Institute to use the right brushes and paint to ensure you get the "picture" right.

I have asked you to chat with me many times. No response is a taken as a refusal to talk. That is unfortunate.

Dear Mr. Garbus:

As an initial matter, we are concerned that you have not read our letter dated September 22, 2017. In your most recent correspondence on September 29, 2017, you stated that had Ms. Anuradha Mittal "been in Tanzania it may be that some of her views would be different." Our September 22, 2017 letter focused in large part on the fact that Ms. Mittal *has already* visited Tanzania, and she has investigated the Maasai's allegations concerning Thomson Safaris during her time in that country. Accordingly, Thomson Safaris' repeated allegations that the Oakland Institute has not been to Tanzania are false. Before a productive conversation can take place, it would be helpful for you to read our correspondence.

Nevertheless, we do agree that it could be productive to have a face-to-face meeting between our clients. Separately, Judi Wineland has contacted Ms. Mittal and also suggested a conversation. The Oakland Institute will not be traveling to Tanzania again, but we invite Ms. Wineland or another representative of Thomson Safaris to meet in Oakland, California, at the Oakland Institute's offices. The clients will speak directly, but the Oakland Institute will have counsel present and Ms. Wineland is welcome to have counsel present as well, should she so choose. Furthermore, the Oakland Institute requires that any meeting between it and Thomson Safaris be recorded, and if the Oakland Institute wishes, the information conveyed in the meeting may be used in the Oakland Institute's report or otherwise disclosed to the public.

Please let us know if Ms. Wineland is willing to meet under the above conditions, and, if she is, what the availability is for such a meeting. This letter does not constitute a waiver or limitation of the Oakland Institute's rights, claims or defenses, all of which are expressly reserved.

I think that Mr. Garbus' suggestion that we go back to the drawing board and chat is a good one. I want you to know that hearing about these old allegations has angered me and I do believe that my emails to you show my incredible frustration with having to continue to try to prove a negative. I want to believe that someone will do their homework. I want to hope that our voice will be heard and carried forward. The story that you are potentially writing has a lot more power when there are allegations of abuse. Our story, which is "that never happened" doesn't get heard.

Your lawyer mentions that you traveled to Tanzania in 2015. Why did you not come to talk to us or step foot in Enashiva. You did not talk to the people of Sukenya. They have a voice and would want to talk to you. Might you consider returning? I am going in early December and would welcome you to come. Enashiva is not part of the Loliondo -Serengeti-OBC debate that is currently happening. It is mentioned that you have spoken to neighbors. Might we at least be able to have a response to those allegations please.

I have asked our lawyer in Tanzania to respond to your legal questions, if he can do so while the appeal is in process. I have asked him to come back to you to correct some blatantly incorrect statements and to provide you a better backdrop of correct information. But, our problem is that I am just not sure he/we can do so while in the appeals process. Do you have access to the court records?

I suggest a phone call. Can we talk?
